

Public Comments

Harris County HUD entitlement programs provided several opportunities for public comment on the PY2013 CAPER during the 2013 program year. These opportunities included public hearings for the Annual Action Plan (AAP), previous year CAPER's and other HUD funding sources such as NSP and Hurricane Ike Disaster Recovery TxCDBG funding. Notices for opportunities for public comment were published in local newspapers prior to each event.

For the PY2013 CAPER, the public was given a 15-day review and comment period prior to its submittal to the U. S. Department of Housing and Urban Development (HUD). A legal notice was published in the *Houston Chronicle*, Spanish newspaper *La Voz* and on the CSD website. The English notice, Spanish and Vietnamese translations of the public notice were posted to our website at www.csd.hctx.net. CSD also sent the public notice to over 500 interested parties via email blast. The public notice informed Harris County residents about the public hearing and opportunity to comment on the documents. The availability of the PY2013 CAPER review was May 7 - 20, 2014.

A public hearing for the CAPER was held May 15, 2014 and there were no public comments.
