JOLIVET JR., 7S22 OBSERVED A VEHICLE TRAVELING WESTBOUND AT THE 3400 BLK OF OST WITH EXPIRED REGISTRATION 04/2012. A TRAFFIC STOP WAS THEN INITIATED ON THE VEHICLE DISPLAYING LICENSE PLATE # 826YFH.</p> <p>AFTER FURTHER INVESTIGATION IT WAS DISCOVERED THAT THE SUSPECT WAS DRIVING A MOTOR VEHICLE WITH A SUSPENDED LICENSE AND HAD (1) OPEN WARRANT FROM H.C.C.02 AND (1) OPEN WARRANT SPRING VALLEY PD. JOLIVET, 7S22 WAS DISPATCHED TO 5290 GRIGGS IN REFERENCE TO A HARASSMENT CALL. THE COMPLAINANT STATED THAT THE SUSPECT WHO IS NOW MARRIED TO HER EX-BOYFRIEND HAS BEEN HARASSING HER FOR THE LAST 6 MONTHS. THE COMPLAINANT STATED THAT THE SUSPECT ON NUMEROUS OCCASIONS HAS CALLED HER ON HER CELL PHONE THREATENING HER AND HER CHILD. THE SUSPECT HAS REPEATEDLY GONE TO HER PLACE OF EMPLOYMENT AND HAS HARASSED HER THERE IN FRONT OF THE STORE MANAGER AS WELL AS OTHER EMPLOYEES. THE SUSPECT HAS GONE TO THE COMPLAINANTS APARTMENT AND LEAVES THREATENING NOTES ON HER VEHICLE IN ADDITION TO LEAVING A VOICE MAIL THREATENING HER NOT TO BE AROUND HER HUSBAND.</p>

THE MALE BECAME FRUSTRATED WHEN THE FEMALE DID NOT ANSWER SO HE TOOK HER GATORADE BOTTLE AND SPLASHED THE CONTENTS ON HER.
