Creator Sketch:

One of five children, Joseph A. Jachimczyk (Dr. Joe) was born September 15, 1923, in Bridgeport, Connecticut to Michael and Mary Jachimczyk. After graduating from St. John Kanty Prep in Erie, Pennsylvania in 1941, Jachimczyk joined the United States Army. He finished his undergraduate education and began medical school at the University of Mississippi prior to his discharge in 1945. He completed the two-year program at the University of Mississippi in 1946 and continued at the University of Tennessee where he graduated with a Doctor of Medicine on March 22, 1948. After completing an internship and residencies in pathology from 1949 to 1953 in Hawaii, Pennsylvania, Connecticut, and Ohio, Jachimczyk worked in the Medical Examiner's Office for six months in Maryland before moving to Boston in 1954. He was employed by the United States Public Health Service from 1954 to 1956 and Harvard University from 1956 to 1957 while he attended Boston College Law School. He received his law degree in 1958.

In 1957 Jachimczyk was recruited by Dr. Jared E. Clarke, Harris County's Medical Examiner, to be Harris County's first forensic pathologist. Dr. Clarke resigned on September 1, 1960, and Jachimczyk became the Chief Medical Examiner, professionalizing the role of Medical Examiner in Harris County.

Dr. Jachimczyk made numerous improvements to Harris County's Medical Examiner's Office by constantly fighting to increase funding, personnel, equipment, and space. The

operations of the morgue were often divided between inadequate locations creating a backlog of forensic evidence that frequently resulted in the delay of trials. By 1984 the Joseph A. Jachimczyk Forensic Center was dedicated near the Texas Medical Center on Old Spanish Trail Road, Houston, Texas. In 1991 the center was expanded by an additional 50,000 square feet to keep pace with Harris County's growing population.

Dr. Jachimczyk's thirty-eight year career defined the Medical Examiner's Office in Harris County. He personally combined the medial and legal roles related to death in an effort to solve crimes. His work was not without controversy. Not only did he solve cases where the cause of death was incorrectly diagnosed, but on occasion he would also miss a homicide. He dealt with mass murders and serial killers. Jachimczyk had an interest in high profile national cases such as Marilyn Monroe's death. He also participated in the Court of Last Resort, a group of professionals dedicated to justice working with detective writer Earl Stanley Gardner.

In addition to his duties at the Medical Examiner's Office, Dr. Jachimczyk lectured medical and legal groups concerning the value of forensic science. He received numerous awards including in 1995 the first Endowed Professorship in Forensic Pathology from the Board of Regents of the University of Texas and the Gift of Sight award from the National Eye Bank.

Dr. Jachimczyk was active in the Polish community, Kanty Alumni Association, and was a deacon at St. Vincent de Paul Parish, Houston, Texas. In 1976, he obtained a Bachelors of Theology from the University of St. Thomas. He died December 7, 2004, at 81 years of age.

Joseph Jachimczyk married Loretta Slomski in 1950. They had four children: Jane, Michael, Peggy, and Mary Lou.

Collection Summary:

Newspaper clippings, printed materials, photographs, correspondence, autopsy case files, and artifacts, document the personal and professional work of Dr. Joseph A. Jachimczyk (1923-2004), Harris County's Chief Medical Examiner (1960-1995) for 35 years. The collection is divided into nine series: Correspondence, Subject Files, Legal, Creative Works, Printed Materials, Monographs, Photographs, Scrapbooks, and Artifacts.

Kennedy, and correspondence and newspaper clippings recording his friendship with writer Earle Stanley Gardner (1958-2002).
