

Harris County Archives MC003 -- Abstracts of Title

An abstract of title, often prepared by a title company, traces the conveyances and encumbrances on a piece of property from the original grant forward. It also contains a certification by the abstractor that the history is complete and accurate.

Abstracts are an excellent source of history of a location, not just a specific lot or tract.

The dates given are the date of certification. The abstracts are arranged alphabetically by subdivision and survey, then chronologically.
