Dear Counsel,

The 84th regular session of the Texas Legislature made a number of changes to the law that impact appointments in the probate courts.

Effective September 1st, all lawyers receiving guardianship appointments must be in compliance with the new rules, which are to be found at Texas Estates Code Sec. 1054.201. Your previously issued certification may not be adequate on September 1st. To obtain a new certification you either must complete a four hour course of which one hour shall be alternatives to guardianship; or, an file an addendum to your existing certification showing that you have completed the require additional class to bring your pre-September 1st certificate into compliance with the new law.

If you are interested in receiving appointments and have not received them in the past, please call the court to arrange an interview. Please make sure that the court has received the following items at least two business days before the interview:

- 1. Your completed application.
- 2. Your resume.
- 3. Your guardianship certification.
- 4. Three of your business cards.
