The average taxable value of a residence homestead in Harris County last year was \$119,418. Based on last year's tax rate of \$0.41455 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$495.05.

The average taxable value of a residence homestead in Harris County this year is \$133,147. If the governing body adopts the effective tax rate for this year of \$0.39135 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$521.07.

If the governing body adopts the proposed tax rate of \$0.41731 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$555.64.

The average taxable value of a residence homestead in Harris County Hospital District last year was \$119,418. Based on last year's tax rate of \$0.17000 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$203.01.

The average taxable value of a residence homestead in Harris County Hospital District this year is \$133,147. If the governing body adopts the effective tax rate for this year of \$0.15989 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$212.89.

If the governing body adopts the proposed tax rate of \$0.17000 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$226.35.

Schedule F - Enhanced Indigent Health Care Expenditures

The Harris County Hospital District spent \$665,290,000 from March 1, 2013 to February 28, 2014 on enhanced indigent health care at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$98,610,000.
