

NOTICE OF TAX REVENUE INCREASE

The Harris County conducted public hearings on October 7, 2014 and October 14, 2014 on a proposal to increase the total tax revenues of the Harris County from properties on the tax roll in the preceding year by 6.63 percent.

The total tax revenue proposed to be raised last year at last year's tax rate of \$0.41455 for each \$100 of taxable value was \$1,324,664,604.

The total tax revenue proposed to be raised this year at the proposed tax rate of \$0.41731 for each \$100 of taxable value, excluding tax revenue to be raised from new property added to the tax roll this year, is \$1,403,027,097.

The total tax revenue proposed to be raised this year at the proposed tax rate of \$0.41731 for each \$100 of taxable value, including tax revenue to be raised from new property added to the tax roll this year, is \$1,436,995,220.

The Harris County Flood Control District conducted public hearings on October 7, 2014 and October 14, 2014 on a proposal to increase the total tax revenues of the Harris County Flood Control District from properties on the tax roll in the preceding year by 2.93 percent.

The total tax revenue proposed to be raised last year at last year's tax rate of \$0.02827 for each \$100 of taxable value was \$87,228,069.

The total tax revenue proposed to be raised this year at the proposed tax rate of \$0.02736 for each \$100 of taxable value, excluding tax revenue to be raised from new property added to the tax roll this year, is \$89,353,917.

The total tax revenue proposed to be raised last year at last year's tax rate of \$0.17000 for each \$100 of taxable value was \$524,930,117.

The total tax revenue proposed to be raised this year at the proposed tax rate of \$0.17000 for each \$100 of taxable value, excluding tax revenue to be raised from new property added to the tax roll this year, is \$557,185,658.
