The average taxable value of a residence homestead in Harris County last year was \$147,338. Based on last year's tax rate of \$0.41923 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$617.69.

The average taxable value of a residence homestead in Harris County this year is \$160,837. If the governing body adopts the effective tax rate for this year of \$0.40960 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$658.79.

The average taxable value of a residence homestead in Harris County Hospital District last year was \$147,338. Based on last year's tax rate of \$0.17000 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$250.47.

The average taxable value of a residence homestead in Harris County Hospital District this year is \$160,837. If the governing body adopts the effective tax rate for this year of \$0.16505 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$265.46.

If the governing body adopts the proposed tax rate of \$0.17179 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$276.30.
