The average taxable value of a residence homestead in Harris County last year was \$131,795. Based on last year's tax rate of \$0.41731 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$549.99.

The average taxable value of a residence homestead in Harris County this year is \$147,975. If the governing body adopts the effective tax rate for this year of \$0.38739 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$573.24.

If the governing body adopts the proposed tax rate of \$0.41923 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$620.36.

The average taxable value of a residence homestead in Harris County Hospital District this year is \$147,974. If the governing body adopts the effective tax rate for this year of \$0.15763 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$233.25.

If the governing body adopts the proposed tax rate of \$0.17000 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$251.56.
